ACKNOWLEDGMENT OF RISKS. Acknowledge that some, but not all, of the risks of participating in the water sport activity include: (1) Changing water flow, tides, currents wave action and ships wakes; (2) Collision with any of the following: other participants, surfboards, the watercraft, other watercraft, and manmade or natural objects; (3) My sense of balance, physical coordination, ability to operate equipment, swim and/or follow directions; (4) The presence of insects and marine life forms, including sharks; (5) Equipment failure or operator error; (6) Heat or sun related injuries or illnesses, including sunburn, sunstroke or dehydration; (7) fatigue, chill and/or dizziness which may diminish my/our reaction time and increase the risk of an accident. 2.
